Limitation: Limited to CRES 0.375" OD x 0.020" wall
- **PPS 6.18, Issue 10 - Certification of Tooling used for Installation of Externally Swaged (Permaswage Type) Fittings**

NOTE (PPS 6.18): Test Assembly is not conforming to Figure 1. Any additional Gaps that Tube-Fab will identify when reviewing PPS requirements while updating in-process documentation. PSD's to PPS 6.18 is required.

NOTE (general): Tube Fab to update WIs/ Travelers/ TFPSs to include PPS 6.13 & 6.18 requirements, as well as related PPSs e.g. PPS 9.05 clean caps. Verification step will be added on traveler for scratches.

- **PPS 6.14, Issue 19 - Swage Installation of Wiggins and Hydraflow Fittings**
VPS 6.14 and VAPS 174-009
Limitation: Limited to Swaging of fittings onto Aluminum Fluid Lines

This approval will be maintained on the condition that your company continues to comply with **DQD 4.6-40 Supplier Requirements Manual** and maintains acceptable product delivery performance.

De Havilland Quality may elect to audit your facility at any time during or prior to any contract, in order to:

- Assure continuing compliance with contractual and quality requirements.
